The meeting discussion was started with item wise and noted.

Item No 1:

To read and confirm the minutes of 10th meeting of BoS, Civil Engineering held in Civil Engineering Department on Saturday 9 th February, 2019

The minutes of tenth BoS meeting held on 9 th February, 2019 was discussed and confirmed by all the members unanimously

Item No 2:

To note and approve the action taken by department on the agenda points discussed and resolved in the ninth meeting of BoS.

Changes suggested by BoS members in syllabus were carried out and the revised syllabus was approved by academic council. BoS approved the action taken by department.

Item No 3:

To discuss and approve the syllabus of Fifth and Sixth semester of BTech Civil Engineering

The faculty of concerned course of the department framed the curriculum of third year BTech Civil Engineering. After discussion in BoS meeting, following points were approved for incorporation in new curriculum

- CE 304U (C) Earthquake engg to be introduce IS 13920 in curriculum
- Changes in CE 310 U Hydraulic engg Lab
- Remove the photogrammetry surveying from CE 354 U Advanced Surveying
- Change the course name of CE 354 U(B), Rehabilitation of building to Rehabilitation of structures and add the rehabilitation of bridge, dams and pavements and demolition aspect to be added.
- Remove the maintenance and rehabilitation of prestressed concrete structure from CE 354 U Prestressed concrete and add it in CE354 U (B).
- Rearrange the practical's of CE 357U Geotechnical engg lab as group A, group B and

- group C
- CE 358 U, Laboratory to be extended and elaborated
 - Add GIS application including mobile mapping practical in CE 359 U(A) Advanced Surveying lab.
 - Modify the experiments of CE 359U (C) Prestressed Concrete lab.
 - CE 359 (D) , Elaborate labwork and modify list
 - Add Water Gem and Sewer Gem in CE360 U software engg lab

BoS authorized Chairman to revised the curriculum structure and curriculum, if required as per the institute requirement

Item No 4:

To discuss and approve paper setters' and examiners' panel for F.Y, S.Y, T.Y. and B.Tech Civil Engineering for the academic year 2019-20 second semester

BoS also approved panel of examiners for Summer 2020 examination. BoS authorized Chairman to revised the panel if required

Item No 5:

Any other point by the permission of chair.

a) Degree with major and minor program

Bos discussed the award of degree in major with minor from other discipline. BoS approved the same, if University permits to deliver B.Tech degree with major and minor, the institute should go ahead with the proposal. It was also suggested to academic council that present 172 credit will be offered as major and additional 12 credit to be earned by student for getting a degree with minors.


b) Post facto approval for examiner panels of winter 2019-20


