Meeting started with welcome of all Hon. Members by chairman. Following points of the agenda notes were discussed at length and some suggestions and conclusions were drawn unanimously which are given below

Item No 1

To read and confirm the minutes of Seventh meeting of Board of studies of Instrumentation Engineering Department held in the meeting hall of department on Saturday, April 7th; 2018.

Chairman briefed to all members about the actions on the minutes of meeting of seventh BOS which were noted and confirmed.

Item No 2

To note and approve the action taken by department on the agenda points discussed and resolved in the Seventh meeting of BoS.

BoS noted and approved the action taken by department on the agenda points discussed and resolved in the seventh meeting of BoS.

Item No 3

To note improvements/additions in academic facilities of the department and other achievements of the department after the seventh meeting of BoS.

Chairman briefed that, NAAC expert team conducted on-site evaluation of the institute on 30/11/2018. Institute has been accredited with B+ grade valid for the period of 5 years. BOS has noted and communicated contentment for the same.

Item No 4

To discuss and approve the new syllabus for SYBTech courses under proposed new structure.

Approved new curriculum structure and syllabus for SYBTech courses under new structure, discussed thoroughly by BOS. Following points are resolved-

- External BOS members were not satisfied with the COs mentioned for majority of courses.
- Departmental level faculty committee should be appointed for the finalization of COs for each course as per bloom's taxonomy.
- The same should be discussed thoroughly in DFB and put forth in next BOS meet.
- The equivalence for the current autonomy students should be taken care of.
- BOS has authorized DFB to include the suggestions received by APEC.

Item No 5

To note and discuss the result and result analysis of Summer-18/Winter-2018.

The clear count of students promoted from lower class to higher class should be put forth next BOS meet.

Item No 6

To discuss and approve the credit transfer policy for online NPTEL courses done by students and its equivalence.

BOS has discussed and suggested that it should be encouraged-

- Student can opt only one course per semester for credit transfer
- Student will register for both the courses in MIS for example IN255N (NPTEL Digital Electronic Circuit) and IN255 (Digital Circuit Design) at the start of the semester.
 - o If student passes the NPTEL exam, registration of the IN255 (Digital Circuit Design) will be cancelled for that session.
 - If student fails the NPTEL exam, registration of the IN255N (NPTEL Digital Electronic Circuit) will be cancelled and the internal evaluation of the IN255 (Digital Circuit Design) will be carried forward for the Re-exam. The further grading will be as per current autonomy rules.

Item No 7

To discuss the formation of panel of experts and course coordinators for various courses in second year, third year and final year Instrumentation curriculum.

7.1 Course-wise course coordinators' for various courses in second, third and final year have been discussed and BOS expressed satisfaction.
